Case records should be well maintained in respect of case analysis, evaluation and repertorisation and made available In record room for academic purpose of the students and follow up attendance of the patient. Case sheet should have complete demographic details and contact details of the patients. Diagnosis should be written in ICD 11 criteria.

Considering the above observations and facilities available, MARBH has decided to issue **Conditional Permission for functioning of Shri Gujrati Samaj Shrimati Kamlaben Raoji Bhai Patel, Gujrati Homeopathic Medical college & Hospital, Research centre, 1, Naisa road, Education Complex Sch. No. 54, Vijay Nagar, Indore-452010, Madhya Pradesh, with intake capacity of 100 seats in BHMS course for the A.Y. 2024-25**

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 seats for BHMS course shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT Govt. as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical

Permission to the college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
